2. Why are you seeking this office? **To fulfill a public service responsibility.**
3. What education, skills and experiences have prepared you to deal with the complex financial, technical and legal issues that regularly come before the village board? **My previous jobs included Corporate Controller, Purchasing Manager and Continuous Improvement Coordinator. I negotiated multi-million dollar purchasing contracts both domestically and internationally.**
4. What, if anything, should the Village of Glen Carbon do to retain, expand and attract 'head of household' jobs? **The Village needs to continue its effort to improve the quality of life for its citizens, provide a wide range of recreational, educational and arts and offer governmental services at the lower than average cost.**

5. Identify and prioritize the three most important 'large capital' projects in the village of Glen Carbon. Please justify your prioritization. How do you propose to pay for these projects? **Parks—provides a full range of "free" recreational activities. Water and sewer infrastructure improvements to support both residential and commercial growth. Improve road systems to provide an easy transportation system throughout the Village.**

Specifically, where are those opportunities? **There are always opportunities to reduce expenditures through converting to electronic means of information transfer and bill payments.**
