In making this application for logo signing, applicant expressly agrees:

1. To fully comply with all applicable statutes, rules and regulations of the Department adopted to implement Senate Bill 1257, Chapter 560, Statutes of 1992; and the terms and conditions of any permit issued by the Department relating to the Motorist Services Informational Signing Program. Failure of the applicant to comply, or failure to continue to meet the minimum criteria by which applicant qualified for participation in the program, will result in removal of the business sign and revocation of the permit.
2. To pay all applicable fees, based on the most current Schedule of Fees established by the Department. Permit, rental, service and transfer fees shall be revised and adjusted annually to not less than 25 percent above the estimated cost of placement and maintenance by the Department. All permit fees are due and payable January 1st each year.

3. To deliver at applicant's sole cost and expense, the required business sign, fabricated in accordance with the Department's "Specifications for Gas, Food, Lodging, and Camping Business Signs", to the location specified by the Department within 60 days after receipt of notification that the application has been approved.
4. Upon request by the Department to promptly replace, at applicant's sole cost and expense, any business sign which is lost, stolen, defaced, damaged or destroyed by third parties, or is found by the Department to be in a deteriorated condition regardless of the cause.
6. That the Department reserves the right upon five (5) days written notification to cover or remove any or all business signs in the conduct of maintenance or construction operations, or whenever deemed by the Department to be in the best interests of the Department or the traveling public. If the applicant's business sign is covered or removed for a cumulative period in excess of ten days, the fees paid shall be pro-rated and the Department shall refund the fees for the period(s) during which the sign was covered or removed. Applicant hereby waives any and all claims of damages and costs to the business by reason of their business sign being covered or removed as herein provided.
6. To furnish with this application a sketch, drawing, picture, or other rendering of the message to be placed on the business sign.
7. To indemnify and save harmless the State of California, its officers, agents, and employees from all liability, loss, cost and obligation on account of or arising out of injuries or losses to any person, however occurring, resulting from the use of
