

Request for Proposal – Event Photographer

Event Photographer

The Marion Chamber of Commerce is seeking to engage the services of a Photographer to take high quality digital photography at its upcoming 2018 Annual Dinner. The Photographer will be expected to take photographs during the Annual Auction & Awards Banquet at The Pavilion in Marion on Friday, January 19, 2018 and provide high quality digital photo files for use in print and web.

Scope of Work

The scope of work shall include:

- The Photographer will attend a meeting to clarify the details of the project.
- The Photographer will be responsible for all necessary equipment, photography and editing.
- The Photographer will be required to photograph all portions of the event at the Annual Auction & Awards Banquet on January 19. All photographic services will be provided based on a final schedule, which will follow at a later date and considered an inclusion to this Agreement. The event is tentatively scheduled to run from 5-10 p.m.
- The Photographer will arrive before 5 p.m.
- The Photographer will capture the Wine & Spirit Pull, Silent Auction, Business/Industry of the Year display, Coat Check, Registration, Diamond Drop, Entertainment, Social Hour, appetizers, guests, speakers, award winners, dinner, desserts, drinks, catering, etc. A photo of the Board of Directors will possibly be coordinated by the photographer on the stage before, during or after the event.
- The Photographer will provide the Marion Chamber of Commerce with high quality digital photographs suitable for use in print and web.
- The Marion Chamber of Commerce shall hold the copyright to, and total ownership of, all event photographs.
- The Photographer will provide evidence of current liability insurance.
- All work must be completed by January 31, 2018.
