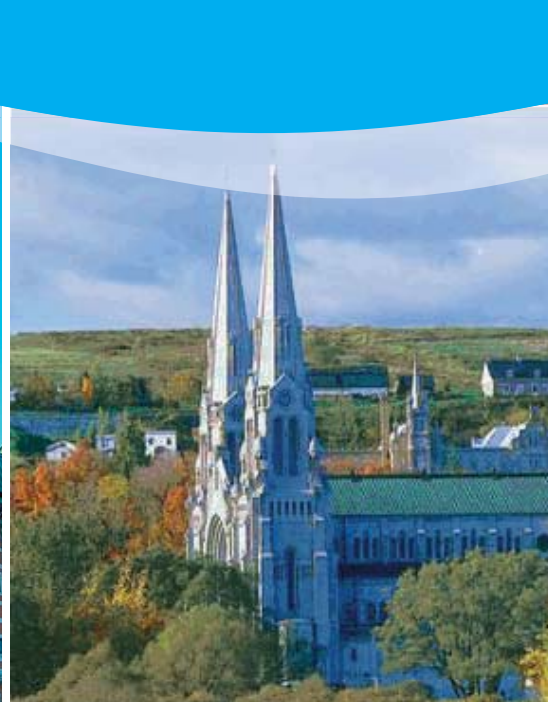
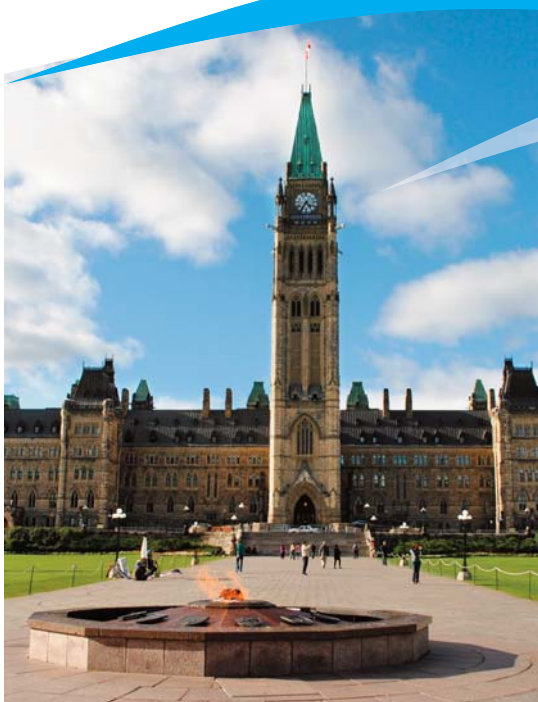

A Canadian Experience

October 13 – Orlando, Florida to Toronto, Canada

Depart from Orlando, FL and arrive in Toronto for this incredible tour that showcases the classic sights and cities of the Canadian east coast. Be welcomed at the airport by your tour guide. Transfer to Niagara Falls for an orientation tour of Niagara Falls followed by a thrilling cruise on board the Hornblower. Overnight in Niagara Falls.

October 14 – Toronto / Chamber Day

After Breakfast, enjoy a day on your own or join your fellow members for a "Chamber Day" - a business day for introducing Canadians to the Melbourne coast. Overnight in Toronto.

October 15 – Toronto / Kingston / Gananoque

Breakfast. Join your guide for a tour of Canada's largest city. You will see the skyscrapers of the downtown core, the harbor front, the CN-Tower, the Eaton Centre and much more. In the afternoon, drive along the shores of Lake Ontario to historic Kingston. Once Canada's capital, Kingston has kept its colonial charm. Overnight in Gananoque, the gateway to the Thousand-Islands.

October 16 – Gananoque / Ottawa / Montreal

Breakfast. Cruise through the famous Thousand Islands. In the late morning, enjoy a city tour of Ottawa, Canada's beautiful capital. Learn about the Canadian political system during a guided visit of the Parliament. Time at leisure to stroll along the Ottawa River, the Byward Market or for an optional visit to the unique Museum of Canadian History (\$). Travel to Montreal in the late afternoon. Time at leisure in the underground city or on famous Ste-Catherine Street. Overnight in the Montreal area.

October 17 – Montreal / La Tuque

This morning discover the highlights of the world's second largest French speaking city: Old Montreal, City Hall, Jacques-Cartier Square, Mont-Royal, the Golden Square Mile and much more. In the late morning, we leave for the dense forests of the Mauricie. Dinner and overnight in a wilderness lodge in La Tuque. (Group dinner at the lodge.)

October 18 – La Tuque / Lake St. Jean / Alma

Breakfast. The morning takes you through Quebec's thick forests and wild landscapes to reach Lac St.Jean, a lake so large it could easily be mistaken for a sea. Visit Val-Jalbert, once a thriving village, it became a ghost town when the local paper mill closed. Possibility of booking an optional excursion to the Zoo Sauvage in St.Félicien (\$). In the afternoon, travel to Alma. Enjoy the relaxing atmosphere of the small town. Overnight in Alma.

October 19 – Alma / Tadoussac / Quebec

Breakfast. Continue along the Saguenay Fjord to Tadoussac. Once a fur trading post, Tadoussac is now famous for the numerous whales that come to feed in the plentiful waters of the St.Lawrence. Walk along the beach or book an optional whale-watching cruise (\$). In the late afternoon, travel through scenic Charlevoix and its typical French-Canadian villages. Upon arrival in Quebec City, guided tour of a reconstructed traditional Huron Indian Village. Overnight in the Quebec City area.

October 20 – Quebec City

Breakfast. This morning discover, with a local city guide, the only walled city in North America. No one can resist the charms of this magnificent city. After the tour you will have time to enjoy the picturesque streets, the shops and the cafés. In the afternoon, discovery tour of the Beauré coast, including a visit of the impressive Ste-Anne basilica. Depart for the Montreal airport for your flight home.

ACCOMMODATIONS:

Price is per person based on double occupancy. When available, single rooms are often smaller than doubles. While GTT will try to match roommates, GTT cannot guarantee a roommate will be available. Roommates may be assigned as late as 35 days prior to departure and, if one is not available or you request a single room, the following charges apply: \$400 during the basic week.

PAYMENT:

A non-refundable deposit of \$300 per person is required. Travel protection premium is due 5/30/16. Final payment for trip is due by 7/30/16. Thereafter, a late payment fee of \$100 will be assessed.

CANCELLATION FEES:

Cancellation Fees may be covered by the optional Travel Protection Program, provided premium has been paid and reason for cancellation is insurable. Those who do not take travel protection should be aware of the following cancellation penalties: From day of registration to 105 days prior to departure, you will be charged the \$200 non-refundable administrative fee plus any airline fees. Additionally, thereafter, you will be charged any airline penalties and a single room supplement if your cancellation forces your roommate into a single plus the following charges: 104-60 days = \$400; 59-45 days = \$600; 44-31 days = 75% of total cost; 30 days to day of departure = 100% of total cost. Submit cancellation in writing. On or after day of departure, there will be no refund for any services not used.

FIT TO TRAVEL STATEMENT:

Passengers registering for the tour accept the responsibility for being in good health and able to walk and travel on the tour. Because many of the sites are not accessible to the physically challenged, those needing oxygen, wheelchairs, or other ambulatory assistance will find the tour extremely limiting to their experiences. If you have questions, please contact Gerry Blanchard for more details.

PRICE INCREASES:

All prices quoted in this brochure are subject to change prior to payment in full due to currency fluctuations, fuel surcharge increases, government taxes and fees increases or unforeseen circumstances. In addition, you may be subject to a price increase after payment in full has been received due to potential government imposed taxes and fees.

AIRLINE ROUTES and TICKETS:

In order to keep prices low, GTT does not guarantee the most direct routing to your final destination. Once "printed," airline tickets cannot be changed or refunded thereafter. Air transportation to/from your destination will be economy class on IATA and ARC carriers utilizing APEX or SUPER APEX non-refundable, non-amendable tickets for groups of 10 or more flying together on entire itinerary.

FLIGHT TIMES:

All flights are subject to change by the airlines without advance notice. GTT is not responsible for such changes or delays and does not reimburse expenses resulting from such delays. If you are making your own flight arrangements to the departure city, we recommend you purchase a ticket that can be exchanged without large penalties.

ADDITIONAL AIRLINE FEES:

You will likely incur additional airline checked baggage fees that are not included in the price of the tour. These fees vary by airline and are at the airline's discretion on each segment of the flight itinerary. Additionally, you may incur optional fees (food, excess baggage, overweight baggage, items of personal nature, etc.) as well. For more information, contact Gerry Blanchard.

DEVIATIONS:

Deviations from the standard tour program must be submitted in writing and are subject to additional airline fees, if applicable. Transfers for passengers who deviate are not included.

ITINERARY CHANGES:

Every effort has been made to ensure the accuracy of this brochure. While you will see all sites listed in this brochure, the order of sites and/or days and number of days may be altered to accommodate changes in airline, hotel schedules, and local conditions. Due to airline schedules, some participants may receive one or two extra leisure days at a nominal per day charge and some extensions may not be available on all departure dates. If itinerary changes necessitate extra overnights, you will be charged \$125 per night; single rooms \$175 per night. Meals for extra nights are not included.

VALIDITY DATE:

This brochure is valid until 4/5/16. If validity date has passed, contact Gerry Blanchard. Registrations will still be accepted after the validity date.
