Dear Friends and Family,

In September 1982, I came home from my office thinking I was coming down with a virus. I wound up at the hospital and after multiple tests, exams, and speaking with multiple doctors, I received a diagnosis of ulcerative colitis. After a stint from September 1982 – December 1982, I walked out of the hospital with my colon and my sanity in tact and I felt very blessed. Except for occasional bouts with my colitis, I have to say I am very fortunate that I have been in remission for many years.

Politically, we've used the expression "we've got to tear down the wall" and I want to clear the pathway to find a cure for Crohn's and colitis in my lifetime. So, I am training to run my first half marathon with Team Challenge on June 4th at the Virginia Wine Country Half Marathon! My motivation to do this half marathon, which is surely a challenge for me, was a very inspirational young man, Ty, who was diagnosed with Crohn's Disease at a very young age.

Ty was not just diagnosed with Crohn's Disease. He went through a whirlwind of a year with mis-diagnosis after mis-diagnosis, test after test, and ultimately a stay in the psychiatric ward because the doctors could not find out what was wrong with him. That is why much needed funds still need to be raised so further research can be done and a cure can be found. Due to Ty's disease, he is unable to walk this half marathon. Well here I am and I have promised to do it in his place! Can you believe that a 17-year-old boy is not well enough to put his body through this but this Senior is?

I will be completing the 13.1 mile race to raise funds and awareness for research leading to a cure for Crohn's disease and ulcerative colitis. Over the next 4 months I will be pounding the pavement, here in South Florida, walking and raising funds to find a cure for this disease that has claimed over 1.4 million Americans.

Crohn's disease and ulcerative colitis are known together as inflammatory bowel disease (IBD). Crohn's disease and ulcerative colitis are painful, medically incurable illnesses that attack the digestive system. The cause of IBD remains unknown. However, the effectiveness of recently developed treatment methods and steady advances in research brings us closer every day to finding the cause and probable cure of Crohn's disease and ulcerative colitis.

My goal is to raise \$3,200 for Team Challenge and the Crohn's & Colitis Foundation of America, as well as to finish the race for Ty. Over 80% of every dollar I raise will directly fund the mission of CCFA, to cure Crohn's disease and ulcerative colitis, and to improve the quality of life of children and adults affected by inflammatory bowel diseases.

I have made a commitment to walk this half marathon and bring us 13.1 miles closer to providing hope, peace, and freedom to individuals battling IBD. I am hopeful you will join me in the fight against Crohn's disease and ulcerative colitis.
