# MISSION & VALUES

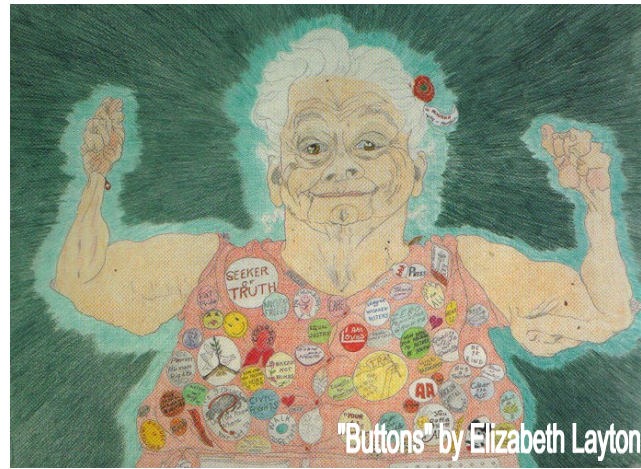

# Our Mission

The Elizabeth Layton Center provides comprehensive and integrated behavioral health services for our community.

## ADULT SERVICES

ELC's Adult Behavioral Health services offer an evidence-based approach for adults struggling with mental health and/or substance use challenges. At the time of the initial assessment, a Qualified Mental Health Professional will gather presenting and historical information, provide initial diagnostic impressions, and collaborate with you in treatment planning and service engagement. Each person is unique and ELC's treatment approach is tailored to individual needs. Services may include:

- Individual, family, and group therapy
- Psychological Testing (e.g. Diagnostic, IQ)
- Competency to Stand Trial evaluation
- Psychoeducation
- Medication Management referral
- Psychiatric Rehabilitation referral
- Care Coordination

## CHILDREN & FAMILY SERVICES

Services are provided to children and their families to assist in the stability of the family. ELC adopts a collaborative systems approach, ensuring that treatment for youth is well coordinated for best outcomes. Children and Family Services include:

- Individual, family, and group therapy
- Play therapy & Parent/child interactive therapy
- Parenting skills groups
- Psychological Testing (e.g. ADHD, IQ)
- Medication Management referral
- Psychiatric Rehabilitation referral
- Care Coordination



## MEDICATION MANAGEMENT

Some behavioral health conditions can be treated with a combination of therapeutic intervention and medication. The evaluation for psychiatric medication is performed by a Psychiatrist or Advanced Practice Registered Nurse and includes coordination of care with client-identified partners like family physicians.

Medication is a tool which may assist individuals in receiving the maximum benefit from other behavioral health services. Response to medication is closely monitored to ensure maximum benefits with minimal side effects. ELC uses the "Just In Time" method of medication appointment scheduling to maximize access.

## SUBSTANCE USE TREATMENT

ELC offers evidence-based treatment for those seeking help with substance use, including alcohol drugs and tobacco. Supportive services are also available for family members. Services include:

- Group, individual and family therapy
- Psychological and court-order testing
- Senate Bill 123 evaluation and treatment
- Medication Assisted Treatment
- Dual Diagnosis treatment for combination substance and mental health needs
- Referral for voluntary detoxification services
- Care Coordination

## CRISIS MANAGEMENT SERVICES

Mental health crisis services are available in our community 24/7 for those struggling with suicidal thoughts or other behavioral health crises. Contact our offices during business hours, or after-hours at 800-241-1266. Crisis services include:

- Crisis phone counseling
- Assessment and referral for psychiatric hospitalization
- Mobile crisis response
- 988 post-call service engagement
- Care Coordination

## COMMUNITY BASED SERVICES

Rehabilitation services for youth qualifying with a serious emotional disturbance. Services include:

- Case Management
- Psychosocial group and individual service
- Parent-Peer support services and training
- Programming for preschool children focusing on social emotional regulation (STEPS)
- Attendant care
- SED Waiver determination and services
- Care Coordination

## COMMUNITY SUPPORT SERVICES

Rehabilitation services for adults qualifying with severe and persistent mental illness. Services include:

- Case Management
- Psychosocial group and individual service
- Peer Support Services
- Attendant Care
- Supported Housing Program
- Supported Employment (Individual Placement & Support)
- SOAR disability application support
- Care Coordination
