

EVENT DATE:

CASA of the Fourth Judicial District, serving Anderson, Coffey, Franklin, and Osage Counties, will be hosting DENIM DAYS for CASA during the entire month of April 2024.

SUMMARY:

CASA of the Fourth Judicial District is asking the community to get involved in Child Abuse Awareness Month by participating in our Denim Days for CASA event. We are looking for offices/organizations/groups, big and small, to select a day during the month of April to encourage their employees to make a donation (there is no set amount – it could be \$3, \$5, \$10, or whatever amount the office chooses) and wear jeans instead of their regular attire.

HOW TO SIGN UP:

You can register for our DENIM DAYS for CASA event by emailing our Executive Director, Jaimie Needham, at JNeedham@FranklinCoKS.org. She will then send you a DENIM DAYS for CASA event kit. You will need to let her know which day in April your office has selected so that we can update our online event calendar with your office's name, as well as an estimation of how many participants your office will have.
