Booth areas that are rented become the responsibility of the vendor and the Lincoln County liability insurance will not cover those areas in case of an accident. Therefore, we recommend that each vendor purchase liability insurance.

A \$20 temporary Lincoln County permit “HUCKSTER BUSINESS PERMIT” is now required for all “for profit” (non profits are exempt) businesses and vendors doing business in Lincoln County. Complete the attached permit application and return it with a check or money order made payable to “**Lincoln County Business License Dept**” and return it with this registration form. Your permit will be available upon your arrival in Pioche.
