

REMEMBERING SEPTEMBER 11, 2001

The September 11 attacks were a series of four coordinated suicide attacks upon the United States in New York City and Washington, D.C. on September 11, 2001. On that morning, 19 terrorists from the Islamist militant group al-Qaeda hijacked four passenger jets. The hijackers intentionally crashed two planes, American Airlines Flight 11 and United Airlines Flight 175, into the Twin Towers of the World Trade Center in New York City; both towers collapsed within two hours. Hijackers crashed American Airlines Flight 77 into the Pentagon in Arlington, Virginia. The fourth jet, United Airlines Flight 93, crashed into a field near Shanksville, Pennsylvania after passengers attempted to take control before it could

reach the hijacker's intended target in Washington, D.C. Nearly 3,000 died in the attacks. In May 2011, after years at large, bin Laden was found and killed. The destruction caused serious damage to the economy of Lower Manhattan. Cleanup of the World Trade Center site was completed in May 2002. The National September 11 Memorial & Museum is open 10 years later. Adjacent to the memorial the 1,776 feet One World Trade Center is estimated for completion by 2013. The Pentagon was repaired within a year, and the Pentagon Memorial opened, adjacent to the building, in 2008. Ground was broken for the Flight 93 National Memorial in November 2009, and the memorial was formally dedicated on September 10, 2011.
