New this year, participating vendors do not have to get an Itinerant Vendor Business License from the City of St. Peters - our license covers you for the day. This is a \$50 savings to participating vendors. Vendors conducting sales, however, will still have the obligation with the Missouri Department of Revenue for sales tax collection, recording and remittance.

Exhibitor Details:
