

Co-chairs: Tommy Kenville, ISight Drone Services and Michael Fridolfs, Northrop Grumman Corp.


Purpose: Convene UAS Sector leaders from across ND to discuss and act on key issues and opportunities for UAS in ND.

Mayor's Base Enhancement Committee

Goal: Secure new missions, capabilities and infrastructure for Grand Forks AFB

Objectives:

- Maintain close relationship with US Air Force leadership at national and local levels.
- Maintain close relationship and open communication with US Senators John Hoeven and Kevin Cramer and US Representative Julie Fedorchak on new mission recruitment and base retention strategy.
- Leverage the ND Base Retention Grant funding (\$250,000 for the 2025-2027 biennium) to develop and execute base enhancement strategy. Focus is on Base land, air and electromagnetic spectrum encroachment, artic strategy brand awareness of synergistic UAS opportunities at Grand Sky and ISR strategy in space.
 - The Chamber was awarded the \$250,000 Base Retention Grant by the North Dakota Department of Commerce
- Secure future base enhancement funding.



BRIC (Base Retention and Investment Committee)

A partnership of the City of Grand Forks, Grand Forks County, The Grand Forks Region EDC, UND and The Chamber. The members of BRIC are all members of The Chamber.

Mission: Share information among all local groups interfacing with GFAFB.

Vision: A fully operating base of the future with multiple long term relevant missions. A base near capacity with new infrastructure, many personnel well positioned for future base closure rounds. A base with alternative uses incorporated into the overall base plan including the Grand Sky UAS Business Park.

Goals:

- Support & enhance the value of Grand Forks AFB, its infrastructure and current missions.
- Engage the public and private sectors to leverage the assets and infrastructure of Grand Forks AFB for economic diversification opportunities to strengthen the Grand Forks Region and State economies.
- Support Grand Sky, UND and the emerging UAS industry in North Dakota.

Chamber Partnership with UND and NCTC

The Chamber partners with the University of North Dakota and Northland Community & Technical College in many areas in support of both UND and NCTC's strategic plans including: internships, Job Fairs, Coulee to Columbia, start-up community projects, connecting students to area employers through service learning opportunities and supporting their legislative priorities.



Workforce Development Committee

A coalition lead by the EDC and supported by Job Service, School Districts and Area Human Resource Professionals.

Purpose: To develop strategies to increase workforce availability for area employers.

Goals:

- Support Career Impact Academy Funding and Implementation.
- Tell the Grand Forks story through the "Grand Forks is Cooler" web site. Drive new resident and potential employee traffic to the "Grand Forks is Cooler" web site.
- Career Expo - Provide opportunities to directly expose regional high school students to career opportunities in the Upper Red River Valley
- Promote and Distribute a "New Residents Guide."
- The Chamber, EDC and UND Career Services will continue to partner on new internships for UND students at area businesses.
- Pursue ND Commerce and Workforce Development Council funds.
- Educate Businesses on Immigration and VISA workforce opportunities.



GF Legislative Priority Committee (Team GF)

A coalition of The Chamber, The GF Region EDC, The City of GF, GF County, UND and other entities as necessary.

Purpose: To identify key infrastructure, funding and policy needs and work with elected officials at the state and local level to promote the Grand Forks legislative agenda.

Historically, over \$1.4 billion dollars in funding has been secured.

Develop and promote 2027 ND Legislative Priorities. Build relationships with legislators locally and statewide.



EGF Intergovernmental Committee

A coalition of The Chamber, The EGF EDHA, The City of EGF, NCTC and Polk County.

Purpose: Meet annually to identify key infrastructure and policy needs and work with elected officials at the state and local level to promote the East Grand Forks legislative agenda.

2026 MN Legislative Priorities:

- Support bonding for Northland Community & Tech. College.
- Support the Greater MN Cities agenda.
- Increase awareness of NW MN needs among legislators statewide.



East Grand Forks EDA / Chamber Partnership

The EGF EDA and The Chamber continue to meet on a regular basis and continue to do the annual "GROW MN" business visits.

The two organizations will work together to develop new ways to assist existing EGF businesses working with MN DEED.



The two organizations will work together to align marketing focuses among the various groups marketing EGF in 2026.

The Chamber, GF EDC, EGF EDA, city administrators and both mayors meet several times a year to talk about how the two communities can collaborate more in the name of efficiency. The Simplot land sale in 2025 was a result of this work.

Grand Forks Region EDC / Chamber Partnership

The Chamber and the Grand Forks Region Economic Development Corporation partner on many things with each group taking the lead role where appropriate: housing, airport infrastructure development, workforce initiatives, branding and many other projects and programs.

The Chamber and EDC CEO's meet on a monthly basis.

The Chamber, GF EDC, EGF EDA, city administrators and both mayors meet several times a year to talk about how the two communities can collaborate more in the name of efficiency.

Strategic Planning Identifies Top Influences

Chamber Strategic Planning Session Identifies Top Influences Impacting our Region



Chamber Board members, Committee Chairs, and community leaders recently came together for a strategic planning session focused on identifying the key factors shaping our community's future. The goal: to pinpoint community influences that must be addressed to ensure Grand Forks and East Grand Forks continue to thrive.

The session was expertly facilitated by David Brown, longtime CEO of the Omaha Chamber and now with the Rebecca Ryan Group, who guided discussions around current challenges and emerging opportunities.

Participants highlighted several critical influences impacting the region and the Chamber, including:

- 1. Catalytic Leadership.** The chamber must continue to define its vision with what will BE and not with what we DO.
- 2. Digital Transformation & Technological Innovation.** How will the chamber help its members adapt to AI and innovation?
- 3. Political & Social Fragmentation.** Too much us vs them in society. Chambers are good at balancing interests and bringing people together.
- 4. Chamber as Unifiers.** Chambers are a trusted organization that can lead in getting diverse groups working together to solve critical problems for the community.

These insights played a pivotal role in shaping the Chamber's 2026 Plan of Action, allowing the Chamber to proactively address these challenges and drive continued growth and success for the community.

WHAT'S NEW AT THE **Chamber** 2026

AI Training Initiative

Artificial Intelligence will transform the way we all do business in the coming years—much like the personal computer, internet, and email revolutionized productivity in past decades. In 2026, the Chamber will launch a comprehensive initiative to help Grand Forks and East Grand Forks businesses harness the power of AI to boost efficiency and competitiveness.

1. AI Best Practices Series

This program will feature small-group (15 participants) facilitated discussions and hands-on learning focused on practical AI applications. Each two-hour session will explore key topics such as:

Prompt engineering and writing, Presentation and visual design, Content creation
Data and analytics, Productivity and workflow automation, Design and creativity, Collaboration and communication, AI for personal knowledge and learning, Specialized use cases, Advanced experimentation with multiple AI platforms

2. Advanced AI “Hack Group”

Designed for professionals already using AI tools, this peer group offers a collaborative environment to tackle real business challenges. Participants bring their toughest AI problems to the table and work in facilitated teams of 5-7 to find creative solutions. Participation is by application.

Natural Gas Pipeline Task Force

Future growth in the Northern Valley depends on expanding natural gas supply. The Chamber, in partnership with the City and regional stakeholders, will work to secure a new connection to the pipeline system that delivers natural gas from the Bakken to eastern North Dakota.

Women in Business Award

Beginning in 2027, the Chamber will annually recognize an outstanding woman in business at the Chamber Annual Meeting. The Chamber is also assessing all of its awards in 2026 in the Henry Havig and Ambassador of the year Awards.

ND Leadership Tours & Talks

Over the past 15 years, the University of North Dakota campus has been transformed into a world-class facility. Many local business leaders haven't yet experienced the scope of this transformation. This one-day immersive program, offered in April 2026, will give Chamber members an insider's view of UND's new programs, initiatives, and the vibrant energy driving campus innovation.

Public Affairs Redesign

Building on the success of the “Team Grand Forks” model for legislative priorities, the Chamber will expand its public affairs efforts in 2026 to include:

- Eggs & Issues Breakfasts – Regular updates on key legislative and policy matters.
- Candidate Recruitment & Community Education – Initiatives designed to engage, inform, and prepare future leaders at all levels of local government.
