AGREEMENT, WAIVER AND RELEASE OF LIABILITY:

I hereby consent that my son/daughter _____ participates in the activities conducted by Lake Almanor Community Church, Vacation Bible School Camp on the Lake Almanor Community Church Property, 2610 Plumas County A13, Lake Almanor, CA 96137, and I hereby execute the Agreement, Waiver and Release of Liability on his/her behalf. I state that the said minor is physically, mentally and emotionally able to participate independently in all activities. I recognize and acknowledge that there are certain risks of physical injury, including death, damage or loss which can be sustained as a result of participating, in any manner, in any and all activities. I knowingly assume the full risk, whether known or unknown, of any and all activities at Higgins 'Ranch.

Also, I hereby release Lake Almanor Community Church from all liability for any act of negligence or want of ordinary care. In consideration of my child's participation in events organized or sponsored by Lake Almanor Community Church VBS. I waive, release and discharge Lake Almanor Community Church, its directors, officers, employees, agents, and members, their representatives, heirs, executors, and assigns, from any and all claims of liability for injury or damage to my child, myself, or my property arising out of my child's participation. This agreement is binding on my executors, heirs, and assigns.

I expressly waive any rights I may have under California Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."

I agree that I will defend, indemnify, and hold harmless Lake Almanor Community Church, its directors, officers, employees, members, and agents, against all claims, demands and causes of action, including court costs and actual attorney fees, arising from any proceeding or lawsuit brought by or prosecuted for my child's or my benefit, in which this release is upheld.

I, the undersigned parent or guardian of the above participant, in consideration of my minor's participation in Lake Almanor Community Church, VBS events, agree that the terms and conditions of this Agreement, Waiver, and Release of Liability shall be binding as to death or injury or property damage to my minor arising out of his/her participation in events at Lake Almanor Community Church.
