Payments and Contracts due by April 30, 2021, this ensures those setting up at your own location to be included on all advertising and map locations for this event. This event is rain or shine. The novel coronavirus, COVID-19 has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments and the feral and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by hosting a yard sale and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at my yard sale event and I voluntarily agree to assume all of the risks and accept sole responsibility for any illness or injury to myself or anyone attending my yard sale event. I hereby release, covenant not to sue, discharge, and hold harmless the City of Marshall, Marshall Area Chamber of Commerce or Marshall Main Street, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, action, damages, costs of expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on actions, omissions, or negligence, whether a COVID-19 infection occurs before, during, or after participation in the city-wide yard sale event.

I, the undersigned, assume all responsibility and all risk of damages or injuries that may occur to myself, my agents, or employees, including exposure or infection, while preparing for or participating in the Community Wide Yard Sales on May 8, 2021.

In consideration of being allowed to provide a yard sale space, the undersigned, on behalf of myself, my heirs, executors, administrators, and assigns, do agree to indemnify the Marshall Main Street Program the business and building owner(s), the City of Marshall, Illinois, and other person, corporation, agency, business or employee from claims, demands, rights, causes of auction or loss, present or future, whether known, anticipated, unanticipated and resulting from, arising out of incident to my employees or agents preparation for, or participation in Community Wide Yard Sales.
